# Tuckaleechee Spring Camporee 2018

## General Information:

The Tuckaleechee fall camporee will be held at Blount County Training Center on April 27-28, 2018. Units can begin check-in Friday the 27<sup>nd</sup> at 6:00p.m. The cost is \$10 per unit and \$15.00 person. Check-in will be at the Pavilion. Campsites will be given on a first come first serve basis.

The Blount County Training Center is located at 1431 William Blount Dr. Maryville Tn.

While camping at Blount County Training Center please follow these guidelines.

- Anyone who attends the Camporee must turn in a hold harmless form attached to this document. Forms will be collected at the camporee Head-quarters located at Pavilion.
- Two deep leadership is required. Two youth protection trained adult leaders must always be present while your unit is aboard BCSO Training Center.
- Every person attending will need BSA health form Part A and B. Troops will keep Health forms while at the camporee.
- The Field uniform is required for all flag ceremonies and closing campfire.
- Above ground fire places are preferred, fire pits will be aloud, no groundfires. If you dig a fire pit please replace soil and sod before checking out on Sunday.
- Wood at the camp is limited please bring your own firewood.
- The camp has water faucets. Please keep these areas clean.
- Your unit is responsible for their own meals so please plan accordingly.
- Park in designated areas. Weather permitting troop trailers be allowed in camp sites. Wheel chocks may be needed to safely park trailers.
- The camp has male and female restroom facilities. Please keep them clean.
- The camp has neighbors, so please observe quiet times.
- Please follow "Leave No Trace" front country camping rules. Plan on taking your camp trash with you when you leave.
- Sunday Clean up, all troops will provide a 3-man working party to clean the camp common areas.
- Have a great time while camping at Blount County Training Center.

# Tuckaleechee Spring Camporee 2018

## 1. 1<sup>st</sup> Class Orienteering Course

*Materials:* 5 Control Flags, 5 Control punches, Control Cards. Control Map, Course maps.

*Method:* The Scout will form 2-man teams, 3-man teams will be allowed only if patrol has an odd number of scouts. Each team will provide their own compass. Each team will be issued a course map. This will be a timed event time start when a team has been issued course map and given 5 control flags to find. The team will plot their route following the order of the control flags. When the team is ready they may start. When the team find the control flag they must follow the instructions at the flag, measure the height of an object or distance between two points, not all flags will have a task. Successful completion of the course will be the team returning with all five flags found and completion of the tasks at the flag. Winners will be determined the most correctly found points, correct answers to tasks the and fastest time.

Teams control card and maps can be returned to troops leaders after the event has been completed. These will be made available a pone request.

*Method:* After the patrol services a safety brief form the Range safety officer they will fire 10 rounds practice. Change targets and fire 10 rounds for score.

**Indemnity Hold Harmless Agreement**

To the fullest extent permitted by law, the undersigned person ("person" shall include the parent(s) or guardian(s) of a minor participating in the described event or activity) agrees to indemnify and hold Blount County, Tennessee, its elected and appointed officials, employees and volunteers and others working on behalf of Blount County, Tennessee (hereinafter collectively "Blount County") harmless from and against all loss, cost, expense, damage, liability or claims, whether based on tort, contract, or other theory or recovery, arising out of the Blount County Sheriff's Office Training Center, including any bodily injury, sickness or disease (including death resulting at any time there from) which may or could be claimed by the undersigned person or any person claiming by or through the undersigned person and damage or destruction of any property which may or could be claimed by the undersigned person or any person claiming by or through the undersigned person, including the loss of use thereof, based on any act or omission, negligent or otherwise, of Blount County, in connection with or incident to the Blount County Sheriff's Office Training Center scheduled for 4/27-4/29 2018 except that the undersigned person shall not be required to indemnify Blount County for damages caused or resulting from the sole gross negligence of Blount County. The undersigned person shall, at his or her own cost and expense, defend Blount County from and against any such claims and any suit, action, or proceeding which may be commenced there-under, and the undersigned person shall pay any and all judgments which may be recovered in any such suit, action, or proceeding, and any and all expenses including, but not limited to costs, attorney's fees, and settlement expenses which may be incurred therein.
