+ The Chartered Organization's Executive Officer (EO) is typically not the same person as the Charter Organization Representative (COR). EOs are typically Pastors, Congregation Presidents, Civic Club Board Chairs, etc. The COR cannot give permission in lieu of the EO.

++ If anyone at a Scout meeting or activity is positive for COVID-19 or has symptoms and have been in physical contact with Scouts, they must report it to their unit. The unit then must report the incident to GSMC.

* Five Core Actions are Physical distancing, wearing cloth face coverings, proper handwashing, cleaning surfaces and staying home if sick.
