WINTER CAMP PROGRAM

Camp Pellissippi was founded in 1936 and is located on the shores of beautiful Norris Lake. Pellissippi is a rustic camp and utilized year-round. The camp features a campfire area, chapel, parade field, trading post, stage area, shooting range, the historic Winter Lodge, and much more.

Program Structure:

Winter Camp operates from December 27th to December 30th each year. Scouts participate in a single merit badge course each day. There is the option to participate in courses weeklong or just for a day. Courses will take place on December 27th, 28th, 29th, and 30th. Check-out and departure is the evening of December 30th.

Economical: Scouts can attend Winter Camp for just \$110 for the week. Adults are \$60 for the week. Scouts can attend a single day for \$30. Camperships are available for Great Smoky Mountain Council Scouts that qualify. Merit badge fees and special program fees may apply.

Weeklong Campers:

This is for campers staying on camp and participating in a merit badge course all four days. Registration opens October 28th at 8:30am and will close when full or on December 3, 2021, whichever comes first.

Day Campers:

Single day registration is available for Scouts or troops that are not able to attend the whole week. This is for campers commuting to camp to participate for the day and not staying overnight. The registration fee of \$30 per day includes lunch. Scouts are welcome to come early to eat breakfast or stay later to eat dinner for an additional \$5 per meal.

Venture Scouts:

We are happy to see the return of classes specifically made for Venturers. Venturers will have the opportunity to have the whole Winter camp experience but take classes that will help the reach Venturing goals by taking trainings to help them advance or work on earning the Ranger Award

CAMP RESERVATION PROCEDURE

*****REGISTRATION FOR WINTER CAMP IS ON A FIRST-COME FIRST-SERVE BASIS*****

We utilize the online Tentaroo event registration system for Winter Camp. Be prepared to register for merit badge courses as soon as possible. This is due to the increasing popularity of Winter Camp. One tip to help with your unit's registration is to have all Scout and adult information preloaded into Tentaroo beforehand. You can find more information at www.EastTNScouts.org/WinterCamp. There is also a paper registration form available later in this guide.

Please remember that all youth and adults attending camp must be registered members of the BSA and have current Youth Protection Training. Refunds will be handled following the Council's refund policy, see the Council website for details.

Merit Badge Registrations Begins on;

- **Thursday, October 28, 2021 at 8:30am for Weeklong Campers**
- **Thursday, November 4, 2021 at 8:30am for Day Campers**

Registration closes on December 3, 2021 or until camp capacity is reached.

Note for Day Campers: You will need to select the classes you choose and also choose "No Monday Class," "No Tuesday Class," etc. Day Campers will initially be charged \$120 for the week. When a "No Class Day" option is chosen the price will reduce accordingly. The total will equal \$30/day when an option is selected for each of the four days.

PRE-CAMP MEETING

The pre-camp meeting held on Wednesday, December 8th beginning at 6:30 PM. The meeting will be held at the Great Smoky Mountain Council Service Center (1333 Old Weisgarber Rd., Knoxville, TN 37909). There will be an option to participate in the meeting via Zoom. Parents, Scoutmasters, other unit leaders, and troop youth leaders are invited to attend. Provisional Scouts must attend with their parent. All units should have representation at the meeting. This is an opportunity to pay any final fees, verify merit badge schedules, review camp rules and guidelines, learn about any program changes, and ask any questions you may have about camp. The camp site assignments will be available at that time. If you are not able to attend, please contact the camp director to get the information.

MERIT BADGE FEES

Some merit badge courses have an additional fee to attend. These fees are used solely to cover the cost of additional materials and supplies associated with the merit badge.

COVID-19 UPDATES

At the time of this writing, fall of 2021, COVID – 19 is still an issue requiring many changes from our typical camping operations. It is our hope that this issue will largely improve prior to Winter Camp; however, there is no way for us to predict the course of this virus or what the conditions will be in the future. The safety of our Scouts, and those who support the camp operations are priority for the Great Smoky Mountain Council.

Camp Operations will comply with the guidelines in place during the operation of camp activities. These guidelines include CDC Recommendations, State of Tennessee Guidelines or mandates, Anderson and Knox County Health Department, as well as the National and local Council guidelines. If there is a conflict in any of these recommendations the council will rely on its in - house Risk Management and Safety and Health committee(s), as appointed, to resolve conflicts regarding recommendations in order to maintain safe operations. It is possible that operations may be suspended or canceled. The guiding principle will be the safety of our Scouting community.

CAMPERSHIP FUND

The Winter Camp staff believes that no Scout should miss camp because of a financial situation. Scouts can earn money towards their camp fees by taking part in the GSMC Camp Card or Popcorn Sale. Another way is to hold individual/group fundraising projects. If Scouts are still unable to afford camp, the Campership fund can help, if approved.


The Thomas H. Baer Memorial Campership Fund was set up in 1988 to help send Scouts from the Great Smoky Mountain Council to a long-term camp. The fund awards camperships (camp scholarships) based on the need of individual Scouts. Because funds are limited, there is a limit to the number of camperships we can award. Only partial camperships will be awarded so that the funds can be spread among as many Scouts as possible.

All campership requests for Winter Camp MUST be submitted by November 4, 2021. All camperships will be distributed on a funds available basis.

MERIT BADGES AND OTHER PROGRAMS

Many of the merit badges offered at Winter Camp can be completed at camp; however, because of time constraints and requirements, special projects, or other considerations, some merit badges have prerequisites, require special skill levels, or may require a Scout to complete the remaining requirements back home with a merit badge counselor. Weather is also a large factor of how much can be accomplished.

Winter Camp tentatively offers over 50 merit badges and other special programs for the 2021 schedule. All merit badges at Winter Camp will be taught in accordance with the 2021 *Scout BSA Requirements* booklet. Any changes in requirements published before camp starts will be used.

On the listing below the merit badge course is on the left side, with the days of camp listed on the right. The number inside each box represents the number of maximum participants allowed in the class per session. If the box is gray it is not offered on that day.

MERIT BADGES

ANIMATION



Animation merit badge can be completed at camp.

ARCHERY



Archery merit badge can be completed at camp (including qualification shoot). This merit badge will be taught at the TWRA range in Halls. The scouts will be transported there by chartered bus with lunch provided.

ART



Art merit badge can be completed at camp. The Scouts will go on a field trip to the Appalachian art center in Clinton, TN.

AUTOMOTIVE MAINTENANCE



Automotive Maintenance merit badge can be completed at camp.

CAMPING & WILDERNESS SURVIVAL

Camping is Eagle Required



Camping merit badge class will complete all requirements except 4, 5e, 7, 8 and 9. Wilderness survival can be completed at camp. The overnight campout will be scheduled during the week to pick the best weather conditions.

CHEMISTRY



Chemistry merit badge can be completed at camp.

CHESS



Chess merit badge can be completed at camp.

CITIZENSHIP IN THE COMMUNITY, CITIZENSHIP IN THE NATION, AND CITIZENSHIP IN THE WORLD

All 3 Eagle Required



Scouts will complete requirements 1, 2 and 6 for Citizenship in the Community. Scouts will complete requirements 1, 4, 5, 6 and 7 for Citizenship in the Nation. All requirements for Citizenship in the World will be completed at camp.

COLLECTIONS



Collections merit badge require Scouts to bring a collection from home to complete the merit badge. Please do not send any valuable collections. If value or size prohibits the scouts from bringing the collection, then photos of the collection will be accepted. Scouts can complete Stamp Collecting and Coin Collecting merit badges at camp.

COMMUNICATION & PUBLIC SPEAKING

Communications is Eagle Required



Communication merit badge class will complete all requirements except 5, 7 and 8. Public Speaking will complete requirements 1 and 2.

COMPOSITE MATERIALS



Composite Materials merit badge can be completed at camp.

COOKING

Eagle Required



Cooking merit badge will complete all requirements except 4, 5, and 6. These requirements may be completed while at Winter Camp but cannot be guaranteed.

CYCLING

Eagle Required



Cycling is one merit badge course taught on Sunday, Monday, and Tuesday. Tuesday is optional for Scouts signed up for the Cycling course. Tuesday will be the 20-mile ride requirement. Scouts will have the option to sign-up for a different merit badge course if they do not want to join the Cycling course for the 20-miler. They will be riding on the Loyston Point trails near camp. These rides will be cancelled for safety reasons if poor riding conditions exist.

DIGITAL TECHNOLOGY



Digital Technology merit badge can be completed if Scouts bring a copy of their Cyber Chip card.

DUCT TAPE



Duct Tape is one of the best unofficial merit badges. It is a spoof badge. The scouts will learn about duct tape and will make crazy, over-the-top projects. Each scout will receive a duct tape merit badge patch at the end of the week.

ELECTRICITY



Electricity merit badge will complete all requirements except 2, 8, and 9. These can be completed before arriving at camp.

EMERGENCY PREPAREDNESS

Eagle Required



Scouts should complete Emergency Preparedness requirement 1 before arriving at camp. They will not do 2c and 8b in camp.

ENERGY



Scouts should complete Energy merit badge requirement 4 before arriving at camp. This merit badge can be completed at camp.

ENGINEERING



Engineering merit badge can be completed at camp.

ENVIRONMENTAL SCIENCE

Eagle Required



Environmental Science merit badge can be completed at camp.

FINGERPRINTING

New for 2021!



Fingerprinting merit badge can be completed at camp.

FIRST-AID

Eagle Required



This badge covers a great deal of written material, and there are skills to master. Familiarity with knots is extremely important. This badge is recommended for older Scouts. It is highly recommended that CPR instruction, as well as requirements 1,2d, 3c, and 7, be completed prior to camp.

FORESTRY



Forestry merit badge can be completed at camp.

GEOCACHING



Most of Geocaching merit badge can be complete at camp. Requirement #9 typically does not get completed.

INVENTING, SALESMANSHIP, & ENTREPRENEURSHIP



Salesmanship requirement 5 cannot be completed at camp. Inventing and Entrepreneurship merit badges can be completed at camp.

JOURNALISM



Journalism merit badge can be completed at camp. Scout will take a field trip for one of the requirements.

LIFESAVING

Eagle Required



Requirement 1a must be done before camp. Scouts must bring “street clothes” to class as well as swim clothes. The CPR requirement will not be taught in class. Swim checks must be done prior to camp and documented on the appropriate form. There is a blank form at the end of this leaders guide for scouts that need the checks. The swim checks that were done for summer camp are valid for one year. You may reuse the same form. This class will be taught off camp property. Scouts will be transported by chartered bus with lunch provided. Appropriate swim wear is required (swim trunks for males and one-piece swimsuits for females).

MEDICINE



Medicine merit badge can be completed except for requirement 10.

METALWORK



Metalwork merit badge can be completed at camp. Scouts should wear clothes appropriate for metalworking (no polyester).

MUSIC



Music merit badge can be completed at camp. It helps if Scouts have a background in music (band, choir, etc.) but is not required.

NUCLEAR SCIENCE



Nuclear Science merit badge can be completed at camp.

ORIENTEERING



Orienteering merit badge can be completed at camp.

PAINTING



Painting merit badge can be completed camp. Please note that this merit badge is more construction related painting and not art painting.

PERSONAL FITNESS

Eagle Required



Personal Fitness merit badge can be completed except for requirement 8.

PERSONAL MANAGEMENT

Eagle Required



Personal Management merit badge can be completed except for requirements 2 and 8.

PHOTOGRAPHY & MOVIE MAKING



Both photography and moviemaking merit badges can be completed at camp.

PIONEERING



Pioneering merit badge can be completed at camp. A good understanding of knot tying is helpful.

PLUMBING



The plumbing merit badge can be completed at camp.

RADIO



Radio merit badge can be completed at camp.

RIFLE SHOOTING



Rifle Shooting merit badge can be completed at camp (including qualification shoot). This merit badge will be taught at the TWRA range in Halls. The scouts will be transported there by chartered bus with lunch provided.

ROBOTICS



Robotics merit badge can be completed at camp.

SEARCH & RESCUE



Search and Rescue merit badge can be completed at camp.

SHOTGUN SHOOTING



Shotgun Shooting merit badge can be completed at camp (including qualification shoot). This merit badge will be taught at the TWRA range in Halls. The scouts will be transported there by chartered bus with lunch provided.

SIGNS, SIGNALS, & CODES



Signs, Signals, and Codes can be completed at camp.

SOIL & WATER CONVERSATION



Soil & Water Conversation can be completed at camp.

SPORTS



Sports merit badge will complete all requirements except 4.

SUSTAINABILITY

Eagle Required



Sustainability merit badge requires the Scout to complete requirements before arriving at camp; 1, 2 water a, 2 food a, 2 energy b or c, 2 stuff a and 4. We will not complete 5a at camp.

SWIMMING

Eagle Required



Swimming merit badge should be completed at camp if the scout is able. Swim checks must be done prior to camp and documented on the appropriate form. There is a blank form at the end of this leaders guide for scouts that need the checks. The swim checks that were done for summer camp are valid for one year. You may reuse the same form. This class will be taught off camp property. Scouts will be transported by chartered bus with lunch provided. Appropriate swim wear is required (swim trunks for males and one-piece swimsuits for females).

THEATER



Theater merit badge can be completed at camp.

WELDING



Welding merit badge can be completed at camp. Scouts should wear clothes appropriate for welding (no polyester).

Venturing Winter Camp



Introducing... Venturing at Winter Camp! This year, there will be classes specifically made for Venturers. They will have the opportunity to have the whole Winter camp experience but take classes that will help them reach Venturing goals by taking trainings to help them advance or work on earning the Ranger Award. Every day, except for the day where First Aid/CPR will be offered, Venturers will have the option to choose whichever classes they want. They could come up for one or two days or stay the whole week. The class charges or weekly charge for Scouts BSA members will also apply for Venturers, so it will be \$110 for the week (what a deal!) or \$30 for every class if you choose not to stay the whole week. Please see below for the class listings and descriptions.

Note: These classes are also open to older Scouts BSA members who would like to take something that's a little different or are interested in learning more about Venturing! You can still take merit badges as well, or you can take all Venturing classes—it's up to you!

Monday

1. Introduction to Leadership Skills for Crews & Goal Setting/Time Management- During this class, we will complete 2 pieces of training to help you complete the Discovery Award
2. Mentoring & Project Management- Looking to complete training for your Pathfinder or Summit award? If so, then this class is for you.

Tuesday

1. First Aid/CPR- Here, you will complete the First Aid/CPR Requirements for the Ranger Award and Discovery Award.

Wednesday

2. Cooking Ranger Core Requirement- In this class, we will be earning as much as we can for the Cooking Ranger Core Requirement.
3. Personal Safety Awareness Training, Ethical Controversy Discussion Activity, and Crew Officer Orientation- Newer to Venturing? In this class, you will be able to knock out 3 pieces of training required for the first 3 ranks.

Thursday

1. Plants and Wildlife/Ecology/Leave No Trace- During this session, you will work on the Plants and Wildlife and Ecology Ranger Electives as well as the Leave No Trace Core Requirement.
2. Land Navigation- In this class, you will work on your Land Navigation Core Requirement for the Ranger Award.

ADDITIONAL COURSES

CHAINSAW SAFETY CERTIFICATION

For Adult Leaders Only

This course is taught by our Camp Ranger. Participants are asked to bring their own gear for the course. This includes chainsaw, face shield, eye protection, ear protection, gloves, chaps, boots, etc. Please contact the Camp Ranger for more information.

CONSERVATION PROJECT

The conservation project is offered each day just like a merit badge course. It is limited to 12 participants each day. This is open to Scouts and leaders. The conservation team will be working on projects throughout camp.

PAUL BUNYAN AWARD

New for 2021!

Participants can sign up for the Paul Bunyan Award course. This is a two-day course offered on Monday-Tuesday and Wednesday-Thursday. This award is for all Scouts BSA members and includes proper use of wood tools, training others in Totin' Chip skills, and creating an outdoor project.

CAMP ACTIVITIES

WINTER CAMP TRADING POST

The trading post will be set up for Scouts and leaders to buy snacks, camp supplies, Winter Camp swag, and other items. The hours of operation will be posted.

CAMPFIRE

Scouts will have a chance to see the amazing view from our campfire circle overlooking Norris Lake on Monday and Wednesday nights. Monday's program will introduce you to the staff. Wednesday's program will concentrate on the meritorious actions of the Scouts and leaders throughout the week. Units and staff members will also have the opportunity to perform skits and songs on Wednesday.

WARRIOR HIKE

A Winter Camp Tradition

All Scouts and leaders are invited to join us on the Morning Warrior Hikes! The hikes will be held on Tuesday, Wednesday, and Thursday mornings. They begin at 6:30am at the Winter Lodge. To earn the Morning Warrior Hike Award a participant must attend all three hikes. The hikes should take one hour or less to complete. Participants will sign-up at camp if interested.

DESSERT COOK-OFF EXTRAVAGANZA

Attention all youth and adults!!! Showcase your cooking skills in our dessert cook-off! A select few of our lucky, or possibly unlucky, staff will be called upon to judge this event. Participants will need to bring their own equipment and ingredients. Please bring your entry to the Winter Lodge at 7:45pm Tuesday night to be judged.

CAMP PELLISSIPPI CHRISTMAS TREE

Our Camp Ranger will have the Camp Pellissippi Christmas tree set up again this year. Scouts are invited to make ornaments for the tree, using materials found at camp. The ornaments will be saved and hung again for a number of years. If anyone would like to propose any other holiday traditions, please see Ranger Murphy.

LEADER'S AWARD OF AWESOMENESS

Winter camp would not be possible without the leaders who take the time to bring Scouts to camp. To recognize the effort and sacrifice of these leaders we have the Winter Camp Leaders Award of Awesomeness! The requirements for this award will be given out at the pre-camp leaders meeting.

FLAG CEREMONIES

The camp will assemble for flag ceremonies at 9:00am and 4:45pm. Scouts and Leaders are expected to attend the evening flag ceremony in Field Uniform. Troops are asked to assist with flag ceremonies and lead grace before meals. There is not a morning flag ceremony on Monday, December 27th during check-in or Thursday, December 30th during check-out.

LEADER'S MEETING

A Patrol Leaders Council (PLC) will be held each evening directly after dinner at 7:00pm in the Winter Lodge. A brief adult leaders meeting will be held each evening after the PLC. Location and reminders will be announced during flag ceremony announcements.

MEALS AT WINTER CAMP

LEADER LUNCHEON

We would like to thank you by providing a special leader's lunch on Tuesday, December 28th. We will not limit the number of leaders each troop sends to the luncheon; all adult leaders are invited to attend.

MEALS

All meals will be provided at Camp Pellissippi, starting with lunch on Monday December 27th and ending with lunch on Thursday, December 30th. There will be a special Cracker Barrel each night in the Winter Lodge; everyone is invited to come by. Visitors to camp are welcomed to eat with us. There is a \$5-dollar charge for visitors' meals. This can be paid at Camp Admin or the Winter Lodge.

DIETARY RESTRICTIONS

If there are any special dietary needs, please note it on the Dietary Restriction form located in the back of this guide and contact the Camp Director. **All dietary restrictions must be known by the end of the Pre-Camp meeting on Wednesday, December 8th.** This is to ensure adequate time to prepare menus and meet food order deadlines. If food allergies are severe Scouts and leaders have the option to bring their own food and store it safely in the Dining Hall.

CAMP PELLISSIPPI GRACE

Before each meal a Scout will lead grace. Any Scout who wishes to lead the grace should see the Program Director. Please note that Scouts are reverent each in their own way. The scout may say his own grace or can lead the Pellissippi Grace.

"We thank thee oh Lord, for the gifts of today.

Our Scout oath and law will always be, our daily reminder to live for thee."

WINTER CAMP PROVISIONAL TROOP

Provisional Scouts are those Scouts, including those from out-of-council troops, who are unable to attend Winter Camp with their own troop. We recognize that not all troops will be able to attend Winter Camp. Scouts attending camp in a provisional status will be placed together and adult leadership will be provided. Adults wishing to camp with the provisional troop are welcome.

All Scouts applying for the Provisional Troop must abide by Scouting principals such as the Scout Oath and Law. They must be trustworthy, responsible, and friendly towards their fellow provisional troop Scouts.

Scoutmasters should make the reservation form available to any Scout who wants to go to Winter Camp as a "provisional" Scout. Scoutmasters should also assist their Scouts in completing the reservation form, the merit badge/activity sign-up form and the medical forms.

GENERAL INFORMATION

CHECK-IN PROCEDURE

The camp staff will be prepared to check in troops beginning at 8:00am on Monday, December 27th.

Arriving Troops will send a representative to the admin to check-in. The camp administration will collect medical forms, troop rosters, and any unpaid registration and merit badge fees.

Vehicles will be permitted to drive to the campsites to unload gear. Vehicles will not be allowed to remain at the campsites during the week. All vehicles will be moved to the parking area.

HEALTH FORMS

Everyone – youth and adults – must have a current copy of their health form. Please keep the original health form for troop records. Participants staying for the week must bring a copy of their BSA Medical Form parts A, B, and C. This form must be signed by the parents and medical professional and dated within the last year. A copy of the insurance card must be attached to the BSA Medical Form.

Anyone attending for a single day needs parts A and B only. All injuries and ailments must be reported to the Camp Health Officer. A health recheck will be given as deemed necessary to make sure no significant changes have occurred since the physical examination was given. **Scouts or adults who do not have their medical forms or a copy of their insurance card cannot stay overnight or participate in camp programs.**

BE PREPARED. Please double check the medical forms for parent signatures and make copies of all medical forms before arrival at Winter Camp.

EARLY ARRIVAL

Early arrival at Winter Camp is not permitted. All participants will check-in on Monday, December 27th. Check-in will begin at 8:00am. Early arrivals have been allowed in the past but cannot this year. This is due to new National BSA camping standards. The Winter Camp leadership team appreciates your understanding on this matter.

MEDICATIONS

Any prescriptions on camp property must be reported and locked up. Medications should be locked up and administered by the Scoutmaster in camp. In some cases, medications can be locked up and administered by the Camp Health Officer. Emergency medications (epi-pen, immediate allergy relief, inhalers, etc.) should be kept on the users at all times and will not be locked up.

VISITORS

All visitors must check in and out at camp admin. Visitors will be given visitor identification. Visitors to camp are welcomed to eat with us. There is a \$5-dollar charge for visitors' meals. This can be paid at Camp Admin or the Winter Lodge. Visitors can stay overnight but must be registered with the Boy Scouts of America and provide proof of current Youth Protection Training. A COVID screening might be necessary for visitors depending on the policy in place during Winter Camp.

TRANSPORTATION

While driving in camp, please observe the posted speed limit of 10 miles per hour. Each unit is responsible for the safe transportation of its members to and from camp. Transporting Scouts or adults in the bed of a pickup truck or trailer, whether covered or uncovered, is against National BSA policy.

Some merit badge classes will go off site to fulfill requirements. Groups that leave on these field trips will be transported by chartered school bus or by camp volunteers in privately owned vehicles. The vehicles will be properly registered and in good mechanical condition.

Vehicles will be permitted to drive to the campsites to unload gear during check-in. Vehicles will not be allowed to remain at the camp sites during the week. All vehicles will be moved to the parking area.

BIKES IN CAMP

Only participants of the Cycling Merit Badge are permitted to bring their personal bikes to camp. Bikes may only be ridden traveling to cycling merit badge meeting location and on cycling merit badge trail rides.

UNIFORM

The Scouts BSA field uniform should be worn to the evening flag ceremony and evening meal each day. The remainder of time Scouts may wear whatever they choose if it is appropriate. "Skin-tight" clothing is not permitted unless it is appropriately covered. Weather conditions will be a major factor in how the Scouts dress.

SWIMWEAR

Appropriate swim wear is required for Swimming and Lifesaving merit badge courses. For the Great Smoky Mountain Council Winter Camp this is defined as (at least) swim trunks for males and one-piece swimsuits for females.

PET POLICY

Participants and visitors are not permitted to bring dogs or any other animals to Winter Camp except verifiable service animals for those that require it.

***You must provide proof of training from a recognized service animal training provider. In addition, the animal must have visited a veterinarian within 45 days of arrival at camp and have complete up-to-date medical and vaccination records. A statement from a veterinarian stating the animal has no known zoonotic diseases, and is of temperament to be unaffected in its abilities to do its trained tasks when exposed to the camp environment which at times can subject the animal to visual and auditory input such as: crowd running, bike riders, gunshots, and other non-typical stimuli.

WINTER WEATHER

As you know, the weather in East Tennessee in December is very unpredictable. It could be 70 degrees, or it could be 20 degrees. Most likely it will be in the 30's or 40's and wet. The best thing to do is to "Be Prepared." When camping in the winter it is important for the Scouts to be dressed for the weather and to stay dry. They should have layers of insulation under their sleeping bag. Ensure that the Scouts have what they need. There is an equipment checklist at the end of the leaders guide to help them pack.

CHECK-OUT PROCEDURE

Check-out for Troops and provisional Scouts will be held on Thursday, December 30th. Our closing campfire is the day before at 8:00pm on Wednesday, December 29th. We will also have a closing ceremony after lunch at 1:30pm on Thursday, December 30th. The afternoon merit badge session will end at 4:30pm. Camp wide cleanup and packing gear is from 4:30pm to 6:00pm. No participants are allowed to stay the night of Thursday, December 30th.

There is a lot of work to do to break down and clean up camp. Any help before leaving camp is appreciated! Vehicles will be permitted into the sites again to pick up equipment. Once the Troop is clear from the area the leaders should inform the staff so that a final inspection can be performed. The cost of any damages caused will be charged to that unit or provisional Scout. Once the Troop or provisional Scout is ready to leave, they must check out at camp admin.

CAMPSITE FACILITIES

Campsite capacities have increased due to the addition of the Adirondacks. However, **adirondacks cannot be guaranteed for your stay at Winter Camp. Troops and provisional Scouts must bring their own tent. All youth and adults must bring their own tent regardless of what campsite they are staying in.** Troops are also required to provide their own canopy, if desired.

While the National BSA treats adirondacks as “lodging/cabin accommodations,” we require the “tenting” requirements be followed for Camp Pellissippi adirondacks.

The youth protection policy of separate accommodations will be enforced. Separate tenting arrangements must be provided for male and female adults as well as male and female youth. No adult is allowed to stay in the same tent of any youth. Youth sharing Adirondacks must be no more than two years apart in age. Spouses are allowed to share tents.

It is very likely that your unit will be sharing a site with another unit for the best use of available camp space.

HAMMOCK POLICY

Due to safety concerns and damage to the Adirondacks, use of hammocks inside the Adirondacks is strictly prohibited.

Great Smoky Mountain Council Policy for the Use of Hammocks on Council Property

Hammocks are more and more becoming a part of the camping experience at our Scout camps. The use of hammocks at outdoor activities can add a fun highlight to the outdoor experience. Hammocks, however, bring with them their own set of safety and ecological issues. It is the policy of the Great Smoky Mountain Council that, for the safety of our participants, that hammocks will be hung at height no more than waist high of the user at the center point while empty. Hammocks will not be secured to shelters but should be secured to stable trees in the area of the campsite out of main paths and walkways.

For your safety and to extend the life of your hammock, read carefully the manufacturer's guidelines and be sure to hang your hammock in a secure location and attach it only to a stable tree.

- * Selects trees with "tough" bark such as oak, hickory or pine over trees with "thin" bark such as maple or dogwood
- * Securing the hammock must be temporary. No nails, eye bolts, screws, etc. put in trees at any time.
- * 1 1/2 "-2" tension straps are approved while rope is **“not”** approved
- * Secure hammocks to trees 8" in diameter or larger.

The following design is preferred to using trees if installing a hammock post in a campsite.



The most dangerous time when using a hammock is while getting into or out of the hammock. It is the time of greatest instability. Use great care! A hammock is not a toy.

Hammocks should not be attached to any camp structure. The Camp Ranger or Staff has the authority to have a hammock moved or taken down because of the location, support or height it is hanging.

CAMP EMERGENCIES

If an emergency situation occurs, listen for the Camp Emergency Signal. A loud, continuous signal will be the beginning of an emergency situation (whether it is a practice drill or a real occurrence). An emergency vehicle driving through camp will also be using either the vehicle's horn or an air horn to signal an emergency. Listen for three blasts of the horn, repeated continuously.

The staff and campers will treat every sounding of the camp emergency signal as a real situation until given the "all clear" signal. This could also be one long blast of a horn.

The designated shelters are; Winter Lodge, Carter Cabin, Shower House, Cabin #5, and Arthur Woods Lodge.

The ALL CLEAR signal is denoted by four blasts of a vehicle horn, and the camp emergency signal will cease. The chart on the right describes several possible conditions that could happen at camp, and the appropriate action needed.

The use of the buddy system is mandatory at camp. We should never lose just one Scout; we should lose two Scouts.

Situation	Appropriate Action
Lost Camper Drill (LCD)	All campers report to the parade field and staff to their designated area.
Moderate to Severe Thunderstorms	Evacuate to the nearest designated shelter (Winter Lodge, Carter Cabin, Shower House, Cabin #5, and Arthur Woods Lodge)
Tornado	Shelter in a closed building.
Fires	Structure Fires: evacuate the building and stand back 100 yards. Do NOT attempt to fight the fire. Forest Fires: Evacuate to the Parade Field and send a runner to call 911 as soon as possible.
Earthquake	All campers report to the parade field and staff to their designated area.
Floods	Low-lying areas go to higher ground.

SWIM CLASSIFICATION PROCEDURES

The swim classification of individuals participating in a Boy Scouts of America activity is a key element in both Safe Swim Defense and Safety Afloat. **The swim classification tests should be renewed annually, preferably at the beginning of each outdoor season.** Traditionally, the swim classification test has only been conducted at a long-term summer camp. However, there is no restriction that this be the only place the test can be conducted. It may be more useful to conduct the swim classification prior to a unit going to summer camp.

All persons participating in BSA aquatics are classified according to swimming ability. The classification tests and test procedures have been developed and structured to demonstrate a skill level consistent with the circumstances in which the individual will be in the water (e.g., the swimmer's test demonstrates the minimum level of swimming ability for recreational and instructional activity in a confined body of water with a maximum 12-foot depth).

ADMINISTRATION OF SWIM CLASSIFICATION TEST (THE LOCAL COUNCIL CHOOSES ONE OF THESE OPTIONS):

OPTION A (at camp):

The swim classification test is completed the first day by camp aquatics personnel.

OPTION C (At unit level with council-approved aquatics resource people):

The swim classification test done at a unit level should be conducted by one of the following council approved resource people: **Aquatics Instructor, BSA; Aquatics Cub Supervisor; BSA Lifeguard; BSA Swimming & Water Rescue; or other lifeguard, swimming instructor, etc.** When the unit goes to summer camp, each individual will be issued a buddy tag under the direction of the camp aquatics director for use at the camp.

TO THE TEST ADMINISTRATOR

The various components of each test evaluate the several skills essential to the minimum level of swimming ability. **Each step of the test is important and should be followed as listed below:**

SWIMMER'S TEST:

Jump feet first into water over the head in depth, level off, and begin swimming. Swim 75 yards in a strong manner using one or more of the following strokes: sidestroke, breaststroke, trudgen, or crawl; then swim 25 yards using an easy resting backstroke. The 100 yards must be swum continuously and include at least one sharp turn. After completing the swim, rest by floating.

BEGINNER'S TEST:

Jump feet first into water over the head in depth, level off, swim 25 feet on the surface, stop, turn sharply, resume swimming as before, and return to starting place.

WHAT NOT TO BRING TO CAMP

Firearms, ammunition, and bows are not allowed in camp: only those supplied by the Shooting Sports area are to be used. Sheath knives are not allowed at camp. Any such equipment mistakenly brought to camp must be delivered to the Camp Director when the unit checks in. It will be returned when the unit checks out at the end of the week.


In addition, no fireworks are allowed in camp. This is policy of the Boy Scouts of America.

Winter Camp is an outdoor experience with a full schedule of classes and activities. We recommend that items such as tablets, electronic games, and other electronic devices not be brought to camp. **WINTER CAMP IS NOT RESPONSIBLE FOR LOST OR STOLEN ITEMS.**

ELECTRONICS POLICY

No electrical cords are allowed to be run from building to building. This is dangerous, against BSA policy and against County Building Codes.
